WAIT LIST INFORMATION

Licking River Kennel Club is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of **50 entries per trial** will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to **Tuesday, September 1, 2026**. No entries may be withdrawn with a refund after closing on September 1, 2026. **If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry.** Any wait listed entry that does not move off the wait list into the trial will receive a full refund.

ADDITIONAL SITE INFORMATION

Trial Site. It is not appropriate to visit the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future. **There will be no crating inside, we will be crating from cars. Please plan accordingly**

RIBBONS, AWARDS, AND PRIZES

Placement ribbons will be awarded in each class as follows:

First Place.....Blue
Second Place.....Red
Third Place.....Yellow
Fourth Place.....White
Qualifying Score.....Dark Green

A New Title rosette will be awarded to all dog and handler teams finishing a title.

High in Trial

Only teams who participate in the same difficulty level for all elements offered (Container, Interior, Exterior, Buried), and qualify in each are eligible to win **High in Trial**. One High In Trial winner is chosen for each difficulty level; there is no separate High In Trial for the Novice A and Novice B sections. The High in Trial is determined by adding the team's faults across the elements. If there is a tie based on faults, then the team's times across the elements will be summed and the faster-finishing team will win. High In Trial Jr Handler- Awarded to the Junior who qualifies across the most elements with the fewest faults. If two Juniors are tied based on faults, then the faster-finishing Junior will be awarded High In Trial Jr. Teams winning High In Trial will earn rosette.

All ribbons/trophies must be claimed on the day of the trial; none will be mailed. If you must leave, see if someone could get your ribbon.

All exhibitors should obtain a copy of the Regulations for Scent Work Trials by downloading them from the American Kennel Club website.

NO SMOKING IS PERMITTED ON TRIAL SITE

The club will be providing lunches for all, minimum donation of \$5/per person that is not a judge or volunteer.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Licking River Kennel Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Licking River Kennel Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Licking River Kennel Club or any official thereof.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

Dogs pulled after closing because of **injury or other medical condition** are eligible for a refund (minus AKC fees) with a veterinary note. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial

Bitches in season will be refunded the full entry fee. Veterinary notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class of the day of the trial.

EXHIBITOR CHECK-IN: At check-in you will receive your armband number. Once the time and location for check-in is determined all exhibitors will be notified by email.

Exhibitors MUST check-in EACH day they are entered.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

"Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations." Additionally, clubs should include any specific local or state health requirements; for example, proof of rabies vaccination.

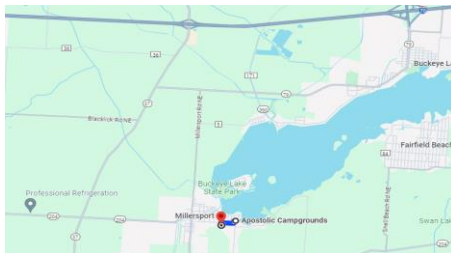

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.
